4a (Code:) (Expenses \$ 464,288. including grants of \$) (Revenue \$) Analysis, Commentary and Field Presence: NCRP engaged philanthropic leaders and advisors, our members and allies, policy makers and the general public in critical discussions about philanthropy and how to improve its practice. We promoted understanding and dialogue about the benefits for nonprofits and society of general operating support, multi-year funding, streamlined application and reporting requirements, mission investing, higher grants payout rates, board and staff diversity, and practices to promote the ethical operation of foundations. We published a quarterly journal (Responsive Philanthropy), worked in coalition with dozens of other groups, held webinars, and promoted dialogue through print, broadcast and electronic media.

4b (Code:) (Expenses \$ 389,415. including grants of \$) (Revenue \$) Philanthropy's Promise: NCRP expanded this signature initiative which celebrates grantmakers that intentionally prioritize and empower people who have been disadvantaged or marginalized in some way. Participating grantmakers make a promise to devote at least half their grant dollars to work that intentionally benefits underserved groups such as economically disadvantaged people, women and girls, the elderly, communities of color, LGBT people and others. Participating funders also pledge to invest in long-term change and empowerment, and they provide NCRP with a public statement about why their foundation subscribes to these principles. To date, more than 140 grantmakers have signed on, and their combined annual giving totals more than \$3.6 billion.

4c (Code:) (Expenses \$ 220,087. including grants of \$) (Revenue \$) High-Impact Strategies for Philanthropy: NCRP published a series of reports and facilitated dialogue throughout the philanthropic and nonprofit sectors that promoted greater understanding of the benefits for society when grantmakers intentionally prioritize marginalized communities and when they invest in promoting democratic participation and systemic change. We tailored our efforts for funders nationwide concerned about education, health, the environment, and the arts. We also held intentional discussions with specific grantmakers, presented at dozens of conferences and fostered discussion of these ideas in print, broadcast and electronic media.
